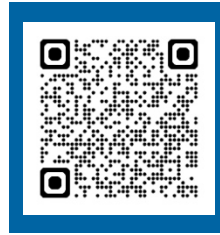

## CANRA/MANDATED REPORTERS

California Child Abuse and Neglect Reporting Act (CANRA) requires employers, including the university, to identify Mandated Reporters (Individuals who are required to report observed or suspected child abuse, assault, or neglect to specified authorities). Mandated Reporters are employees who, by virtue of their position, activities, licensure, or profession, are required under CANRA to report child abuse to specified authorities.

### Employees identified as Mandated Reporters at UCI include:

- UC Irvine Medical Center employees
- Licensed health care professionals
- **Employees who work in youth camps, K-12, and youth outreach programs**
- All employees in the following units/departments: Campus Police Dept., Athletics, Child Care Center Wellness, Health & Counseling Services
- **Other employees and administrators who have contact with children on a regular basis and employees as identified by the campus and/or the employee's department**

## CLERY ACT (1990)

To ensure students, prospective students, parents, and employees have access to accurate information about crimes committed on campus and campus security procedures.

Failure to comply results in penalties, fines, and loss of financial aid for UCI. As of 2024, a fine can be up to \$69,733 per violation.

## RECEIVING A DISCLOSURE OF A CRIMINAL INCIDENT DURING YOUR VISIT AT UCI INVOLVING YOUR MINOR

If the disclosure is about an emergency or crime in progress, call or text 9-1-1. The 9-1-1 message will be directed to the UCI Police Department's dispatch center.

The following are the types of CANRA crimes that need to be reported to UCIPD, should it be disclosed to you by a minor in your program.

- Child to child abuse
- Commercial sexual exploitation (trafficking)
- Corporal punishment of injury
- Harming or injuring
- Neglect
- Sexual assault
- Sexual exploitation (picture/videos)

The following are Clery Act crimes that need to be reported to UCIPD, should it be disclosed to you by a minor in your program:

- Aggravated assault
- Arson
- Burglary
- Dating & domestic violence
- Hate crimes
- Hazing
- Motor vehicle theft
- Murder
- Robbery
- Sexual assault
- Stalking

**DO NOT** investigate the crime. You are not responsible for investigating or determining if a crime took place.

## HOW TO REPORT IMMEDIATELY



### WHO

Call UCIPD at 949-824-5223 to report the crime.



### WHAT

Identify the crime that was shared with you:

- e.g.: Minor student in program disclosed they were **assaulted while they went to the campus bathroom.**



### WHERE

Include the location to where the crime took place:

- e.g.: Minor student in the program disclosed that while they in the **Student Center**, someone punched them in the face.



### WHEN

Include date and time of when the crime took place:

- e.g.: **Saturday, May 4, 2024 at 1 p.m.**
